The 2008 Farm Bill expires on September 30, 2012. Election year politics will make it difficult to finish the bill in 2012, but the House and Senate Agriculture Committees will hold hearings and adopt their versions of the legislation by spring or summer of 2012. The Farm Bill is a massive piece of legislation which authorizes a broad range of programs that are critical to counties. These programs assist counties in the development of rural water/wastewater infrastructure, community facilities, broadband expansion, nutrition assistance, renewable energy, local and regional food systems, support for new farmers, and business development initiatives. 
